AND/OR

Current subspecialty certification or active participation in the examination process leading to subspecialty certification in pediatric endocrinology by the American Board of Pediatrics or the American Osteopathic Board of Pediatrics.

AND

Required previous experience: Applicants for initial appointment must be able to demonstrate provision of inpatient or consultative services, reflective of the scope of privileges requested, to an acceptable volume patients in the past 12 months or demonstrate successful completion of an ACGME- or AOA-accredited residency, clinical fellowship, or research in a clinical setting within the past 12 months.

Reappointment requirements: To be eligible to renew core privileges in pediatric endocrinology, the applicant must meet the following maintenance of privilege criteria:
